Get a helping hand to kick start your farming or crofting business

Setting up a farming or crofting business comes with its challenges. Not only do you need a well-designed business plan, but you will also need to have good knowledge of agriculture and be able to adapt quickly to the unexpected. However, you don't need to do this alone. If you haven't thought about mentoring before, now is the time.

If you're new to farming or have become head of a farming business within the last 5 years, you can take advantage of the free mentoring programme available through the <u>Farm Advisory Service (FAS)</u>*. With access to up to 4 days of one-to-one time with a personal mentor available, you can gain valuable skills and knowledge matched to your business needs.

A recent survey by FAS found that 100% of farmers and crofters who have used its mentoring service would recommend it to others. In addition, over two-thirds of respondents reported benefitting from the following improvements after receiving mentoring support:



- livestock/crop improvements;
- · improved soil management;
- · better business planning/decision making;
- financial benefit from reduced costs/overheads.



How woodland creation could help protect the future of your dairy business

Have you ever thought about the knock-on effects of climate change and what it means for your farm or croft? Long-term changes in the weather bring more droughts, floods and higher temperatures. These can have a big impact on the dairy farming sector because of heat stress in dairy cows.

Cows need to maintain a constant body temperature of around 38.8°C. When ambient temperatures are above 25°C, a cow's performance begins to decline, which can adversely affect the productivity of your business. A new study by the Met Office shows that heat stress in dairy cattle is projected to increase significantly in key dairy regions across South West England and West of Scotland as temperatures rise.

Heat stress happens when an animal's heat load is greater than its capacity to lose heat. Mild heat stress can result in reduced weight gain, decreased fertility and reduced milk yield. More severe heat stress can cause increased morbidity and mortality rates.



Nature-based solutions can help to minimise the risk of heat stress and protect cattle. Pasture and trees can provide additional shade, meaning dairy cattle will be exposed to less direct heat as they are sheltered. Planting 'shelter belts' can also help support biodiversity and sequester carbon, so reducing a farm or croft's carbon footprint.

The <u>Farm Advisory Service (FAS)</u> can provide one-to-one advice on woodland management and climate change mitigation measures to help protect your business. And, the support doesn't end there – you can get **funding of up to £1,000** to help you do this. Specialist advisers can help you choose the right type of woodland to plant in the right place for the right reason.

Improve your farm's efficiency with woodland management and conservation support

If you didn't already know, the <u>Farm Advisory Service (FAS)</u> can provide up to **£1,000 of funding for professional advice** to farmers, land managers and crofters on woodland creation, management and conservation. If you or the business you manage, is in need of advice on anything woodland related including wildlife conservation, business diversification or optimising the use and/or value of land, take advantage of FAS specialist advice and funding available.

A business can choose its own adviser to match its business needs. FAS will then step in by requesting a CV to verify that the adviser is adequately qualified and experienced in the selected field.

The support from FAS is available to all agricultural businesses registered with the Rural Payments and Services, and hold a current Business Registration Number.

There are a number of reasons to apply for a carbon audit, some of them being:

- complying with regulations;
- finding out where performance improvements and savings can be made.

All farming and crofting businesses are able to apply for a fully funded carbon audit, provided that they are registered in Scotland with IACS and are funded by the Scottish Government.
