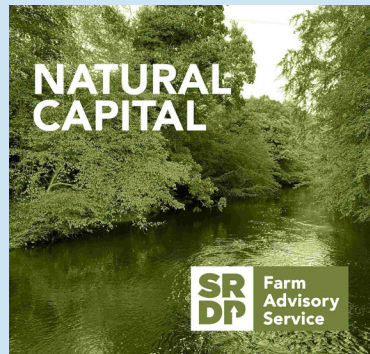

Government-funded advice on succession planning and will writing

Planning the future management of a farm or croft can be the elephant in the room at family dinner tables. Will writing is an essential part of owning a farming business. An up-to-date will can prevent family disputes and probate issues, protect non-farming heirs, help minimise estate taxes and ensure a smoother farm transfer.

Win-win - Crofters' assistance for energy efficient heating

The Croft House Grant (CHG) can help alleviate fuel poverty for some crofters providing them with warmer homes that are cheaper to heat. This grant has recently been updated to include Energy Efficiency options at a higher grant rate to help tackle the Climate Crisis. These improvements mean lower fuel bills and more comfortable homes.

You need an Energy Performance Certificate (EPC) before applying. Applications for energy efficiency improvements may include:

- Under floor insulation
- Loft insulation
- Wall insulation (Cavity, Internal or External)
- Flat roof insulation
- Heating Upgrades and improvements*
- Hot Water system upgrade*
- Thermostats and Heating Controls
- Hot Water Cylinder Insulation
- Solar Thermal Heating
- Solar Photovoltaics
- Window and Door Upgrade

*Limited to zero direct emission heating systems (unless demonstrated that these will not be suitable for the property).

Getting started with an animal health and welfare plan

As part of the Whole Farm Plan, all farmers or crofters who keep any number of cattle, sheep, goats, deer, alpacas, llamas, pigs, or over 350 poultry need to have an animal health and welfare plan completed by at least 15th May 2024 and update this annually.



Recently there has been a shift to more proactive, regular reviews at three-to-four-month intervals to coincide with the production cycle, rather than being viewed as an annual tick box exercise to meet auditing requirements.

Health planning should be farmer-led, but other members of the farm team including farm staff, farm vets, nutritionists, and other consultants will have valuable input in the process.

Livestock health planning is a cycle consisting of four components.

1. Set targets

- Specific, Measurable, Appropriate, Realistic, Time-limited (SMART) goals should be set specific for your farm/croft.
 - These can be based on technical or financial Key Performance Indicators (KPIs) which help you benchmark against other similar enterprises or year-on-year change within your business.
 - E.g. scanning percentages, weaning rates, growth rates.

2. Risk plan

- Establish an action plan for predictable risks.
 - Focus on one production stage (fertility/survival/growth) at a time.

3. Monitor

- Record the minimum data you need to know if you have hit your targets or not. Data recording can be time consuming.

4. Review

- Investigate areas where targets were missed or unexpected things happened with your team.

Tools and templates are available to help you prepare your livestock health plan.
