### Mentoring

We will provide a mentor, experienced in your business sector, to guide you through the critical early years to establish a successful and sustainable business. Their experience, gained through advising many similar businesses, will help you make decisions and become financially viable. Farm Advisory Service (FAS) will match you to a mentor and provide them up to £1,200 to fund four days of their work with you.

#### Fully-funded business review

All new entrants to farming are eligible to receive £2,000 of funding for a fully funded Integrated Land Management Plan. This enables you to bring in an expert adviser who can support you in a number of ways, including:

- Developing a business plan and identifying suitable targets.
- Mapping out the reporting, legal and environmental requirements of the business.
- Identifying what support schemes and information services are available.

# **If you are an established business** of five years or more, here's how we can help:

### **Specialist advice**

No farmer can be an expert in the many issues that have to be addressed.

FAS can support you to find an adviser or you can bring in your own specialist who you trust, be it a farm adviser, conservationist, lawyer or accountant, and FAS funding can help support their work for you<sup>1</sup>.

You are eligible to receive specialist advice support for two topics with £1,600 of funding per topic, including:

- Animal welfare
- · Archaeological and historic sites
- Biodiversity, habitat and landscape
- Carbon audit action plan
- · Climate change adaptation and mitigation
- Crofter's plan
- Farm business efficiency
- Organics

## Expert support to help you review the business and make plans

An Integrated Land Management Plan (ILMP) allows you to bring in an adviser to discuss plans to ensure your farm or croft is profitable and sustainable for the years ahead.

You can choose from a panel of expert consultants who will work with you to support the specific needs of your business. They will look at all aspects of your business from its resources and finances to matters of conservation and biodiversity. Then, together, you will develop a step-by-step action plan enabling you to steer your business to success.

Up to £2,000 of funding is available for this work, which covers up to 80% of the cost.

### Annual carbon audits

There is also support available through FAS for annual carbon audits – open to all farming and crofting businesses – to help identify performance improvements and cost savings. Carried out by an experienced agricultural consultant, there is £660 of funding towards an initial carbon audit and £330 for any repeat audits. Carbon audits will establish your carbon footprint, identify the sources of emissions on your farm and show you how your performance compares with others – highlighting areas where you can improve your farm's operational efficiency. By repeating the carbon audits annually, you can monitor performance and identify the impact of changes you make.
